Berthelot's Pipit, *Anthus berthelotii*, is a species of passerine bird in the wagtail and pipit family found in heathland and shrub and unvegetated or sparsely vegetated land ecosystems. The species is found in the Canary Islands and Madeira where it is sedentary. Birds are found from sea level to over 2,000 m in all habitats except dense woodland and wetter areas. In the eastern Canaries it uses dry, sparsely vegetated semi-desert areas of volcanic rock and other open habitats such as tracks. In the western Canaries it is found in mountainous areas and on rocky hillsides. In Madeira it is most frequently found in the high sierras but can also be found on cliffs and fields near the sea (European Red List 2015).

*Anthus berthelotii* is endemic to the Canary Islands and Madeira and has a breeding population size of 30000-150000 pairs and a breeding range size of 12800 square kilometres in the EU27. The breeding population trend in the EU27 is Unknown in the short term and Unknown in the long term.


The EU population status for *Anthus berthelotii* is Unknown, as the data reported were not sufficient to assess the population status of the species.

## Main pressures and threats reported by Member States

Pressures are activities which are currently having an impact on the species and threats are activities expected to have an impact in the near future. Pressures and threats were ranked in three classes 'high, medium and low importance', the table below only shows pressures and threats classed as 'high', for some species there were less than ten pressures and threats reported as highly important.

## Proportion of population covered by the Natura 2000 network

<sup>i</sup> **Assessment of status at the European level:** The EU assessments of birds population status was made by the European Red List of Birds Consortium (under contract with the European Commission)

The EU27 population trends were assessed using these categories: '+' Increasing, '0' Stable, 'F' Fluctuating, '-' Decreasing, 'xu' Uncertain and 'x' Unknown. The breeding population size is estimated in majority of the cases as 'p' number of pairs. Alternative population units used are: 'males' number of males, 'i' number of individuals, 'cmales' number of calling males and 'bfem' number of breeding females. The winter population size is estimated as number of individuals.

<sup>ii</sup> **Species trends at the Member State level:** The percentage of the EU27 species population occurring in the Member States (% in EU27) is calculated based on the population size reported by the Member States.

<sup>iii</sup> **Percentage of coverage by Natura 2000 sites:** In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (\*). The value 'x' indicates that the Member State has not reported the species population and/or the coverage by Natura 2000. No information is available for Greece and for non-Annex I species in the Czech Republic.
