Alpine Citril Finch, *Carduelis citrinella*, is a species of passerine bird in the finch family found in heathland and shrub and woodland and forest ecosystems. It is endemic to Europe, with its fragmented distribution confined to central and south-west regions of the continent. This species is generally found in montane and submontane woods of spruce (*Picea*), larch (*Larix*) and pine (*Pinus*), usually along the edges and in clearings. It also inhabits scattered clumps of conifers in otherwise open areas, as well as alpine meadows, ski-runs, roadside edges, and around alpine huts and gardens in towns. In the non-breeding season it is found in similar habitats in sheltered valleys at lower levels (European Red List 2015).

Carduelis citrinella has a breeding population size of 243000-262000 pairs and a breeding range size of 176000 square kilometres in the EU27. The breeding population trend in the EU27 is Decreasing in the short term and Fluctuating in the long term.

The EU population status of *Carduelis citrinella* was assessed as Secure, because the species does not meet any of the IUCN Red List criteria for threatened or Near Threatened, or the criteria for Depleted or Declining (the EU27 population or range has not declined by 20% or more since 1980).








ⁱ Assessment of status at the European level: The EU assessments of birds population status was made by the European Red List of Birds Consortium (under contract with the European Commission)

The EU27 population trends were assessed using these categories: '+' Increasing, '0' Stable, 'F' Fluctuating, '-' Decreasing, 'xu' Uncertain and 'x' Unknown. The breeding population size is estimated in majority of the cases as 'p' number of pairs. Alternative population units used are: 'males' number of males, 'i' number of individuals, 'cmales' number of calling males and 'bfem' number of breeding females. The winter population size is estimated as number of individuals.

ⁱⁱSpecies trends at the Member State level: The percentage of the EU27 species population occurring in the Member States (% in EU27) is calculated based on the population size reported by the Member States.

iiiPercentage of coverage by Natura 2000 sites: In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (*). The value 'x' indicates that the Member State has not reported the species population and/or the coverage by Natura 2000. No information is available for Greece and for non-Annex I species in the Czech Republic.
