Eurasian River Warbler, *Locustella fluviatilis*, is a species of passerine bird in the warbler family found in wetland and river and lake ecosystems.

Locustella fluviatilis has a breeding population size of 178000-357000 pairs and a breeding range size of 933000 square kilometres in the EU27. The breeding population trend in the EU27 is Decreasing in the short term and Uncertain in the long term.

The EU population status of *Locustella fluviatilis* was assessed as Threatened, as the species meets one or more of the IUCN Red List criteria for threatened at the EU27 scale.





¹ Assessment of status at the European level: The EU assessments of birds population status was made by the European Red List of Birds Consortium (under contract with the European Commission)

The EU27 population trends were assessed using these categories: '+' Increasing, '0' Stable, 'F' Fluctuating, '-' Decreasing, 'xu' Uncertain and 'x' Unknown. The breeding population size is estimated in majority of the cases as 'p' number of pairs. Alternative population units used are: 'males' number of males, 'i' number of individuals, 'cmales' number of calling males and 'bfem' number of breeding females. The winter population size is estimated as number of individuals.

ⁱⁱSpecies trends at the Member State level: The percentage of the EU27 species population occurring in the Member States (% in EU27) is calculated based on the population size reported by the Member States.
