Savi's Warbler, *Locustella luscinioides*, is a species of passerine bird in the warbler family found in wetland and river and lake ecosystems.

Locustella luscinioides has a breeding population size of 154000-261000 pairs and a breeding range size of 629000 square kilometres in the EU27. The breeding population trend in the EU27 is Unknown in the short term and Unknown in the long term.

The EU population status for *Locustella luscinioides* is Unknown, as the data reported were not sufficient to assess the population status of the species.





Main pressures and threats reported by Member States

For the bird species triggering SPA classification Member States were asked to report the 20 most important pressures and threats using an agreed hierarchical list which can be found on the Article 12 Reference Portal (http://bd.eionet.europa.eu/activities/Reporting/Article 12/reference portal). Pressures are activities which are currently having an impact on the species and threats are activities expected to have an impact in the near future. The table below only contains information from Member States, where a species triggers SPA classification. Pressures and threats were ranked in three classes 'high, medium and low importance', the table below only shows pressures and threats classed as 'high', for some species there were less than ten pressures and threats reported as highly important.

¹ Assessment of status at the European level: The EU assessments of birds population status was made by the European Red List of Birds Consortium (under contract with the European Commission)

The EU27 population trends were assessed using these categories: '+' Increasing, '0' Stable, 'F' Fluctuating, '-' Decreasing, 'xu' Uncertain and 'x' Unknown. The breeding population size is estimated in majority of the cases as 'p' number of pairs. Alternative population units used are: 'males' number of males, 'i' number of individuals, 'cmales' number of calling males and 'bfem' number of breeding females. The winter population size is estimated as number of individuals.

ⁱⁱSpecies trends at the Member State level: The percentage of the EU27 species population occurring in the Member States (% in EU27) is calculated based on the population size reported by the Member States.

iiiPercentage of coverage by Natura 2000 sites: In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (*). The value 'x' indicates that the Member State has not reported the species population and/or the coverage by Natura 2000. No information is available for Greece and for non-Annex I species in the Czech Republic.
