Eurasian Tree Sparrow, *Passer montanus*, is a species of passerine bird in the sparrow family found in cropland and urban ecosystems.

*Passer montanus* has a breeding population size of 9880000-17500000 pairs and a breeding range size of 3230000 square kilometres in the EU27. The breeding population trend in the EU27 is Decreasing in the short term and Decreasing in the long term.

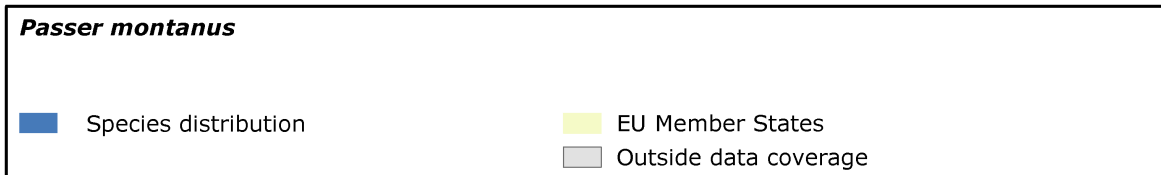
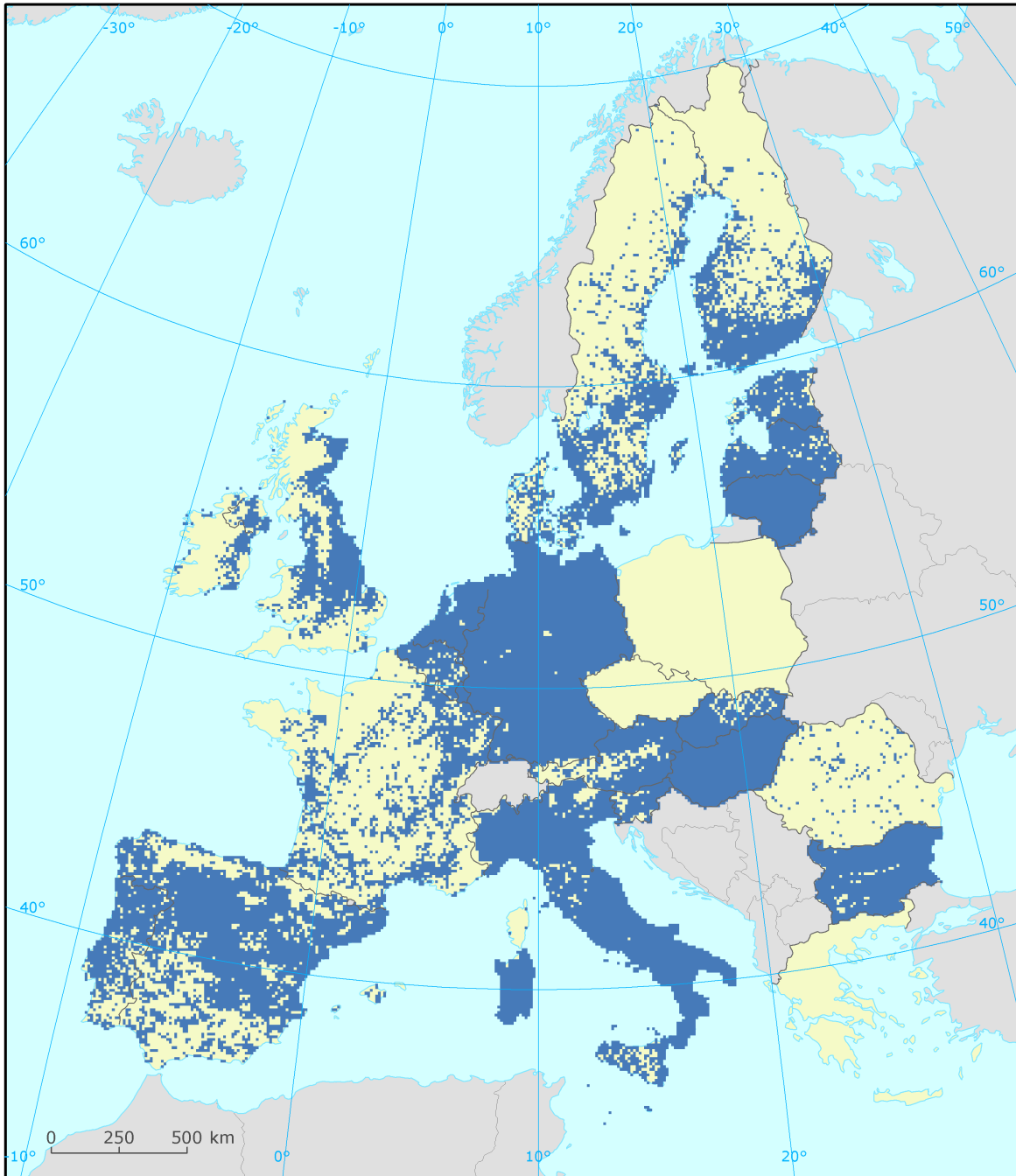
The EU population status of *Passer montanus* was assessed as Declining, because EU27 population or range declined by at least 20% since 1980, with continuing decline since 2001.

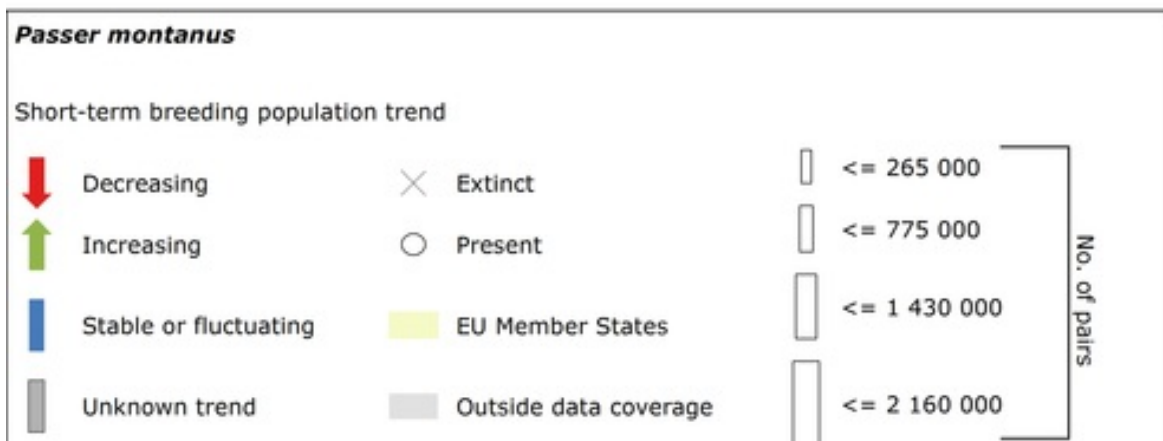
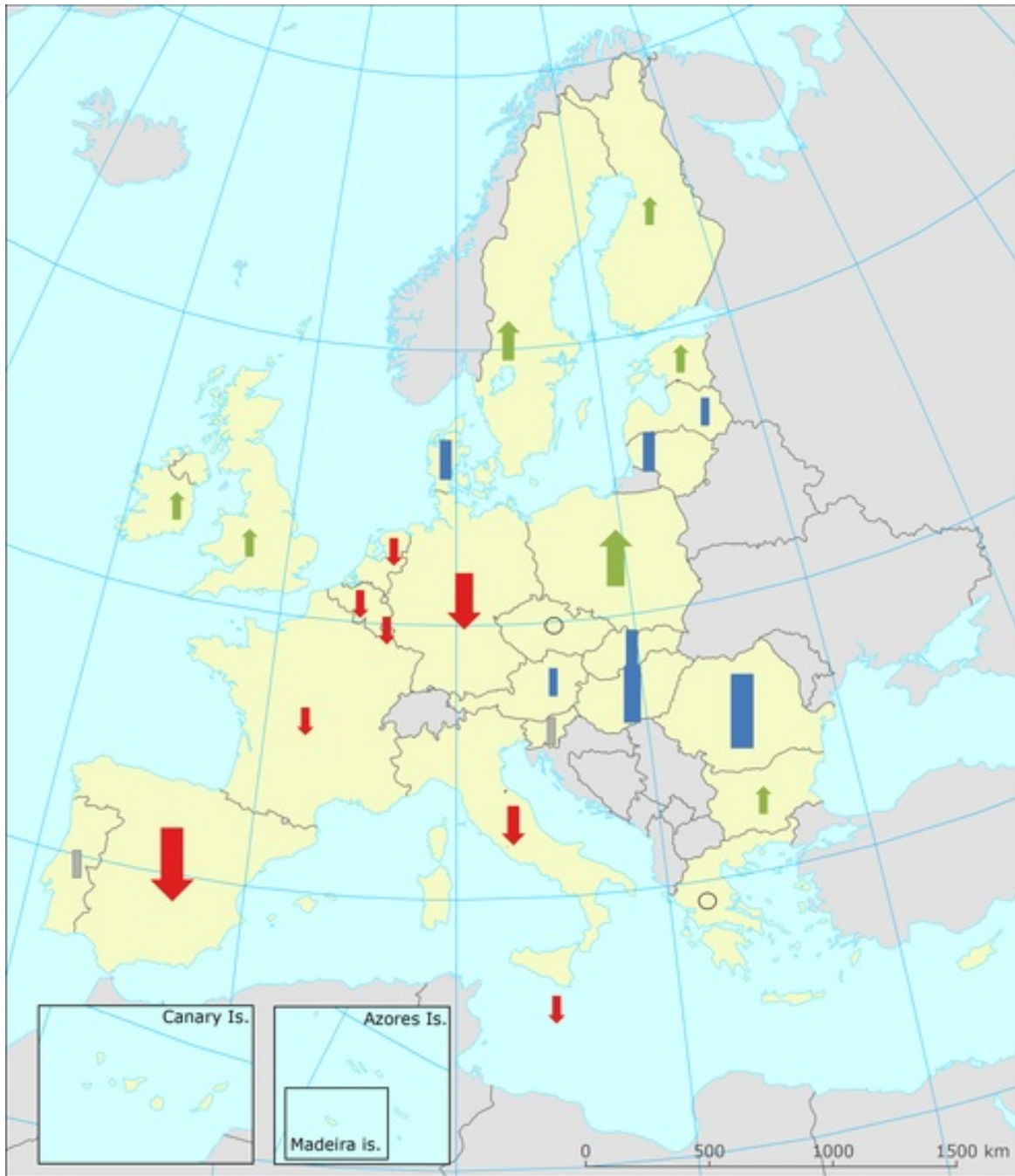

**<sup>i</sup> Assessment of status at the European level:** The EU assessments of birds population status was made by the European Red List of Birds Consortium (under contract with the European Commission)

The EU27 population trends were assessed using these categories: '+' Increasing, '0' Stable, 'F' Fluctuating, '-' Decreasing, 'xu' Uncertain and 'x' Unknown. The breeding population size is estimated in majority of the cases as 'p' number of pairs. Alternative population units used are: 'males' number of males, 'i' number of individuals, 'cmales' number of calling males and 'bfem' number of breeding females. The winter population size is estimated as number of individuals.

**<sup>ii</sup> Species trends at the Member State level:** The percentage of the EU27 species population occurring in the Member States (% in EU27) is calculated based on the population size reported by the Member States.
