Madeira Kinglet, *Regulus madeirensis*, is a species of passerine bird in the kinglet family found in woodland and forest ecosystems.

*Regulus madeirensis* is endemic to the island of Madeira and has a breeding population size of 50000-100000 pairs and a breeding range size of 1800 square kilometres in the EU27. The breeding population trend in the EU27 is Increasing in the short term and Increasing in the long term.

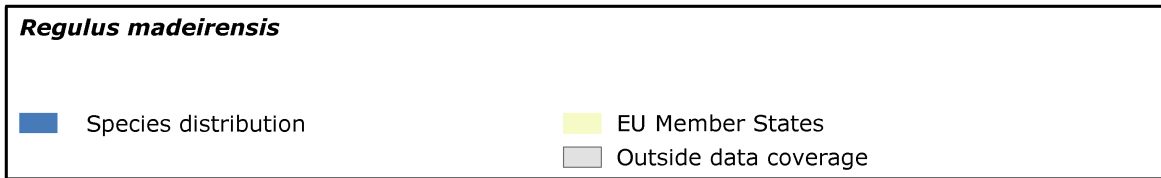
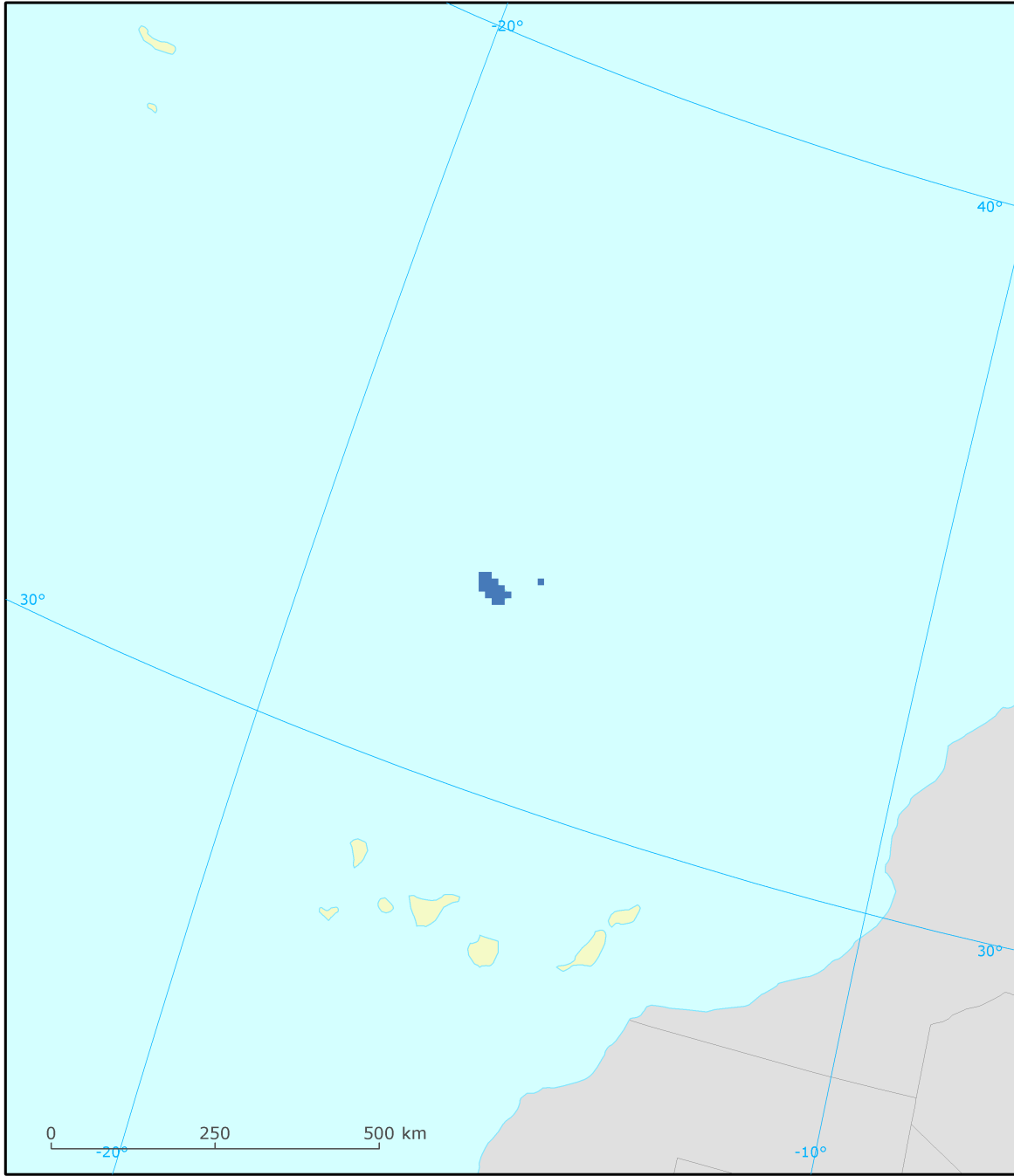
The EU population status of *Regulus madeirensis* was assessed as Secure, because the species does not meet any of the IUCN Red List criteria for threatened or Near Threatened, or the criteria for Depleted or Declining (the EU27 population or range has not declined by 20% or more since 1980).

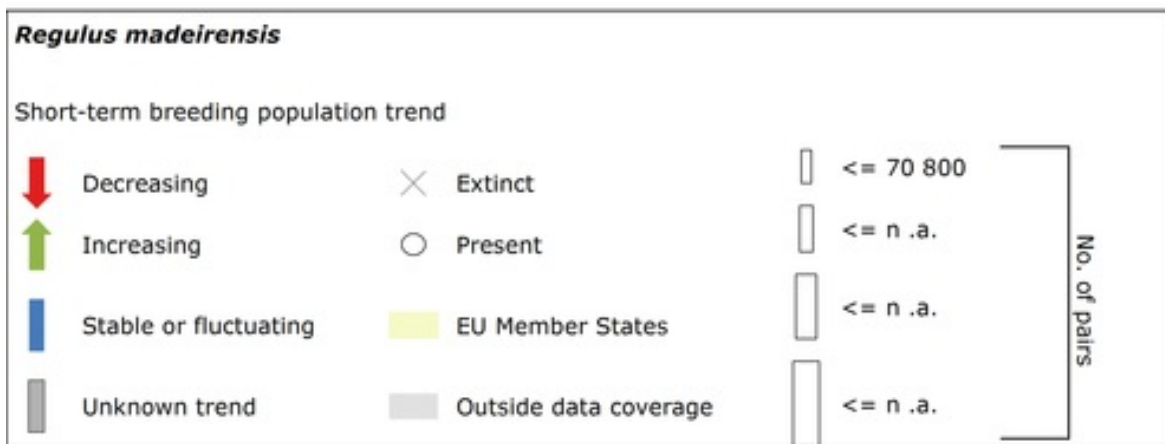

<sup>i</sup> **Assessment of status at the European level:** The EU assessments of birds population status was made by the European Red List of Birds Consortium (under contract with the European Commission)

The EU27 population trends were assessed using these categories: '+' Increasing, '0' Stable, 'F' Fluctuating, '-' Decreasing, 'xu' Uncertain and 'x' Unknown. The breeding population size is estimated in majority of the cases as 'p' number of pairs. Alternative population units used are: 'males' number of males, 'i' number of individuals, 'cmales' number of calling males and 'bfem' number of breeding females. The winter population size is estimated as number of individuals.

<sup>ii</sup> **Species trends at the Member State level:** The percentage of the EU27 species population occurring in the Member States (% in EU27) is calculated based on the population size reported by the Member States.
