Little Bustard, *Tetrax tetrax*, is a species of bustard found in cropland and grassland ecosystems.

Tetrax tetrax has a breeding population size of 56700-112000 males and a breeding range size of 351000 square kilometres in the EU27. The breeding population trend in the EU27 is Decreasing in the short term and Decreasing in the long term.

The EU population status of *Tetrax tetrax* was assessed as Threatened, as the species meets one or more of the IUCN Red List criteria for threatened at the EU27 scale.

This factsheet was produced for *Tetrax tetrax tetrax* [Continental (migratory)] population. Also other subspecies/populations of the same species occur within the EU27. The assessment of status at the European level and the introductory text were done at the species level in line with the criteria for assessment of the EU population status. 



The EU27 population trends were assessed using these categories: '+' Increasing, '0' Stable, 'F' Fluctuating, '-' Decreasing, 'xu' Uncertain and 'x' Unknown. The breeding population size is estimated in majority of the cases as 'p' number of pairs. Alternative population units used are: 'males' number of males, 'i' number of individuals, 'cmales' number of calling males and 'bfem' number of breeding females. The winter population size is estimated as number of individuals.

ⁱⁱSpecies trends at the Member State level: The percentage of the EU27 species population occurring in the Member States (% in EU27) is calculated based on the population size reported by the Member States.

ⁱⁱⁱ**Percentage of coverage by Natura 2000 sites:** In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (*). The value 'x' indicates that the Member State has not reported the species population and/or the coverage by Natura 2000. No information is available for Greece and for non-Annex I species in the Czech Republic.
