*Leucorrhinia caudalis* is a dragonfly which is widely spread across Europe. It depends on swamps and freshwater lakes.

In the Boreal region the species' overall assessment is 'favourable'. In all other geographical regions (Alpine, Atlantic, Continental and Pannonian) it is assessed as 'bad'. However, its status in the most important country (Poland) of the Continental region seems very good. Particularly in France and Hungary this species is doing very badly. The major threats to habitat loss are eutrophication and acidification. Since the population is considered to be very large and stable the IUCN conservation status for this species is 'Least Concern'.


