



Vertigo moulinsiana is a small snail that lives in marshes and swamps across Europe as far north as southern Sweden.

Overall conservation status for the Pannonian region is 'favourable'. Boreal and Atlantic assessments are 'unfavourable-bad'. Continental status is reported by nine countries and the overall assessment is 'unfavourable-inadequate' even if Czech Republic, Denmark and Sweden reports are 'favourable'. Information concerning Mediterranean region is reported by three countries and the status for two of them is 'unknown', resulting in an 'unknown but not favourable' overall status. In the Alpine region there is a deficit of available data, principally from Spain and therefore it is not possible to assess the overall conservation status.

The species was assessed as 'Lower Risk/conservation dependent' by IUCN in 1996 this assessment needs updating.
