



The pond bat is widely spread across Europe and (North) Asia. It lives in lowland areas nearby waters, meadows and woods where it forages on insects.

In all geographical regions (Alpine, Atlantic, Boreal, Continental and Pannonian) its overall status is assessed as 'unknown' or 'inadequate'. In some countries the population trend is positive while in many others it is reported as negative. Despite the positive population trends in Belgium, Germany and Denmark the overall population trend is negative. The IUCN conservation status has recently changed from 'Vulnerable' to 'Near Threatened'.
