



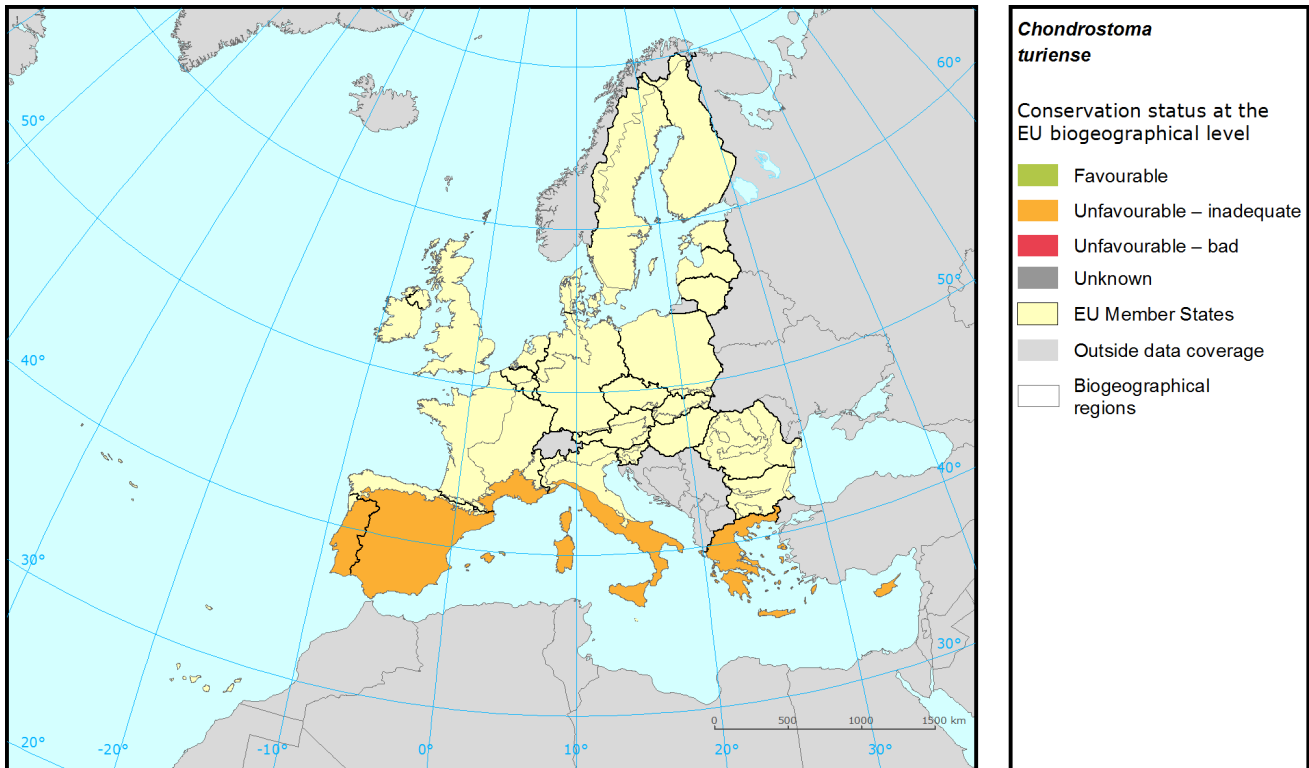

The Spanish populations of *Chondrostoma toxostoma*, the fish from cyprinids family, previously considered as subspecies were recently elevated to the species rank. *Chondrostoma toxostoma* only occurs in France and populations in Spain belong to one of three species: *Ch. meigii*, *Ch. arrigonis* and *Ch. turiensis*. *Chondrostoma turiensis* is an Iberian endemic only occurring in the Turia and Mijares river basins in eastern Spain. It lives in rivers, but it can also survive in reservoirs, if it can migrate to rivers with current for reproduction. The conservation status in the Mediterranean region, the only region where the species occurs, is unfavourable inadequate with improving trend. The species is particularly threatened by regulation of rivers, pollution and alien invasive species. Due to its restricted natural range, decline in population size and habitat area and continuous pressures on its habitat the species is listed as 'endangered' in the European Red List.

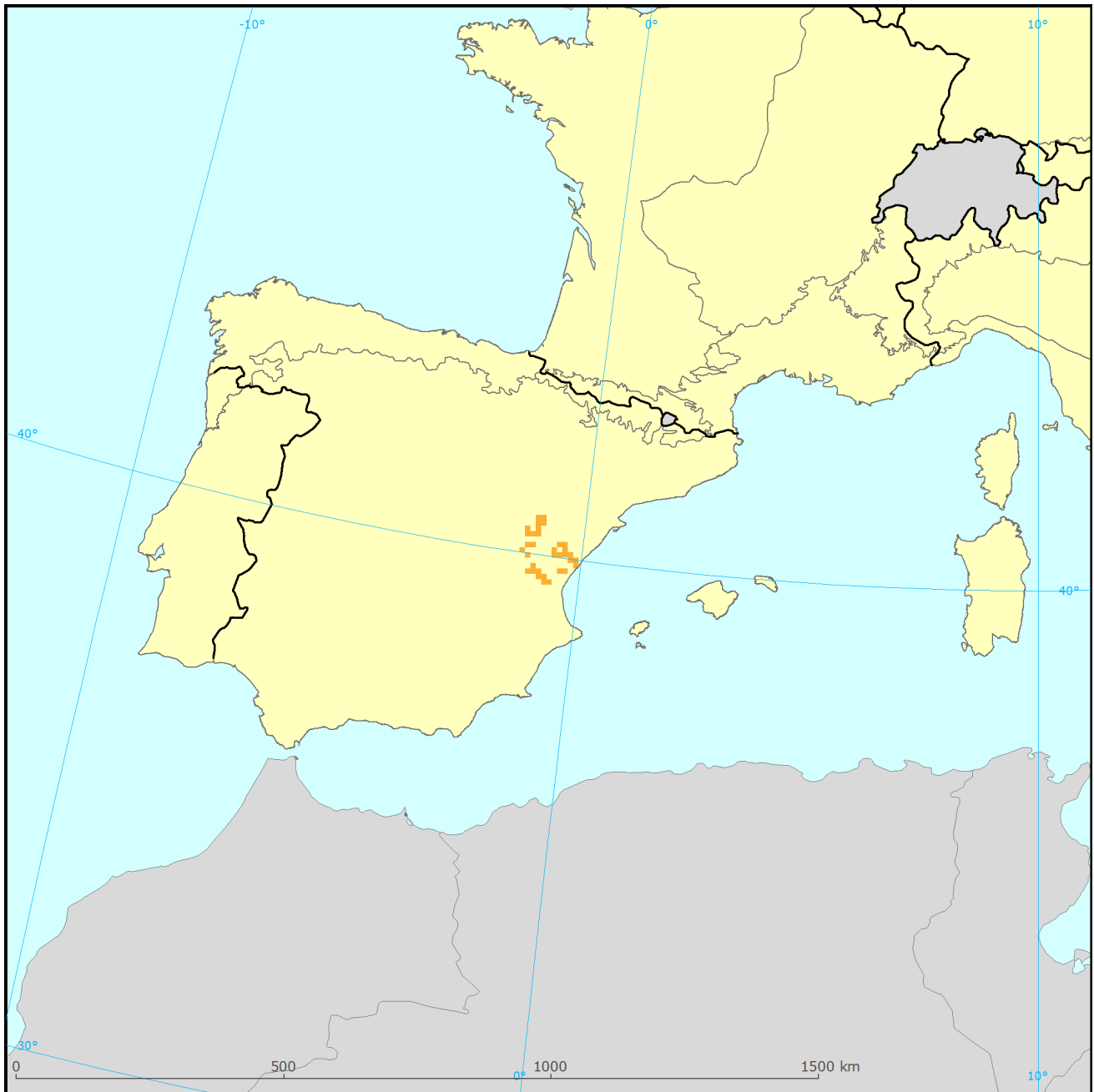

The map shows both Conservation Status and distribution using a 10 km x 10 km grid. Conservation status is assessed at biogeographical level. Therefore the representation in each grid cell is only illustrative.

Knowing that not all changes in conservation status between the reporting periods were genuine, Member States were asked to give the reasons for changes in conservation status. Bulgaria and Romania only joined the EU in 2007 and Greece did not report for 2007-12 so no reason is given for change for these countries. Greek data shown above is from 2001-06.

Main pressures and threats reported by Member States

Member States were asked to report the 20 most important threats and pressures using an agreed hierarchical list which can be found on the [Article 17 Reference Portal](#). Pressures are activities which are currently having an impact on the species and threats are activities expected to have an impact in the near future. Pressures and threats were ranked in three classes 'high, medium and low importance'; the tables below only show threats and pressures classed as 'high', for some species there were less than ten threats or pressures reported as highly important.

Proportion of population covered by the Natura 2000 network

Most frequently reported conservation measures

For species listed in the Annex II of the Directive Member States were asked to report up to 20 conservation measures being implemented for this species using an agreed list which can be found on the Article 17 Reference Portal. Member States were further requested to highlight up to five most important ('highly important') measures; the table below only shows measures classed as 'high', for many species there were less than ten measures reported as highly important.

i Assessment of conservation status at the European biogeographical level: Current Conservation Status (Current CS) shows the status for the reporting period 2007-2012, Previous Conservation Status (Previous CS) for the reporting period 2000-2006. Reason for change in conservation status between the reporting periods indicates whether the changes in the status were genuine or not genuine. Previous Conservation Status was not assessed for Steppic, Black Sea and Marine Black Sea regions. For these regions the Previous status is therefore considered as 'unknown'. The percentage of the species population occurring within the biogeographical/marine region (% in region) is calculated based on the area of GIS distribution.

ii Percentage of coverage by Natura 2000 sites in biogeographical/marine region: In some cases the population size within the Natura 2000 network has been estimated using a different methodology to the estimate of overall population size and this can lead to percentage covers greater than 100%. In such case the value has been given as 100% and highlighted with an asterisk (*). The value 'x' indicates that the Member State has not reported the species population and/or the coverage by Natura 2000. No information is available for Greece. The values are only provided for regions, in which the occurrence of the species has been reported by the Member States.
