Coluber nummifer

The Coin-marked Snake is a snake species reported for the Mediterranean region by Greece and Cyprus. Outside of the EU it is found eastwards in Anatolia, the Middle East and parts of Central Asia. This harmless snake is frequently killed by people, due to its resemblance with the poisonous *Macrovipera lebetina* (blunt nosed viper). According to the IUCN Red List it is found in open areas, including open dry woodland and shrubland, with some rocks and bushy vegetation.

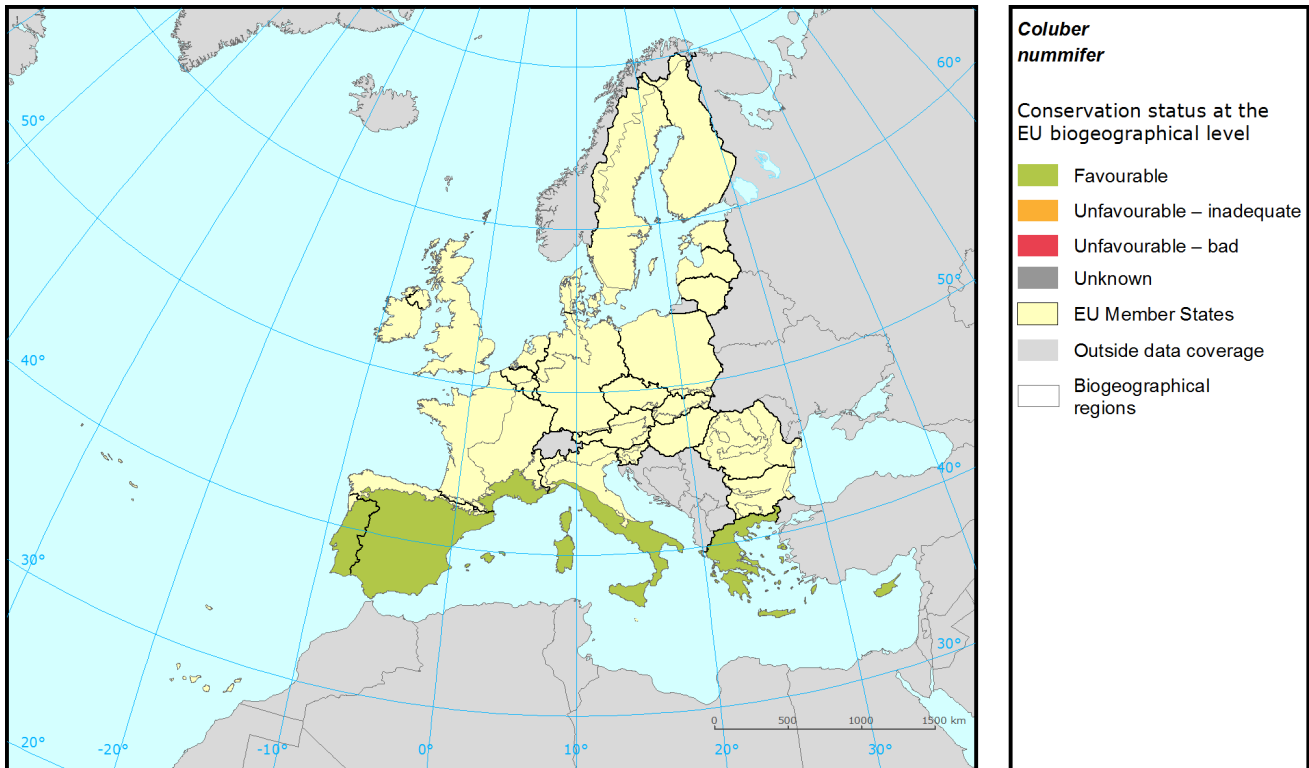
The conservation status for Greece and Cyprus were both reported as 'favourable' and the overall conservation status assessment for the Mediterranean biogeographical region is also 'favourable'. This marks a change from 'unknown' from the previous reporting period for the Cyprus report, whereas the status for Greece remained unchanged as no reports were provided for the current reporting period. Pressures and threats reported by Cyprus are all low-ranking and include urbanisation, fencing, roads and motorways and the removal of stone walls.

The IUCN Red List classifies the species as least concern due to its wide distribution and presumed large population (<http://www.iucnredlist.org/details/157270/1> consulted on 3 March 2015).

Knowing that not all changes in conservation status between the reporting periods were genuine, Member States were asked to give the reasons for changes in conservation status. Bulgaria and Romania only joined the EU in 2007 and Greece did not report for 2007-12 so no reason is given for change for these countries. Greek data shown above is from 2001-06.

Main pressures and threats reported by Member States

Member States were asked to report the 20 most important threats and pressures using an agreed hierarchical list which can be found on the [Article 17 Reference Portal](#). Pressures are activities which are currently having an impact on the species and threats are activities expected to have an impact in the near future. Pressures and threats were ranked in three classes 'high, medium and low importance'; the tables below only show threats and pressures classed as 'high', for some species there were less than ten threats or pressures reported as highly important.

i Assessment of conservation status at the European biogeographical level: Current Conservation Status (Current CS) shows the status for the reporting period 2007-2012, Previous Conservation Status (Previous CS) for the reporting period 2000-2006. Reason for change in conservation status between the reporting periods indicates whether the changes in the status were genuine or not genuine. Previous Conservation Status was not assessed for Steppic, Black Sea and Marine Black Sea regions. For these regions the Previous status is therefore considered as 'unknown'. The percentage of the species population occurring within the biogeographical/marine region (% in region) is calculated based on the area of GIS distribution.
