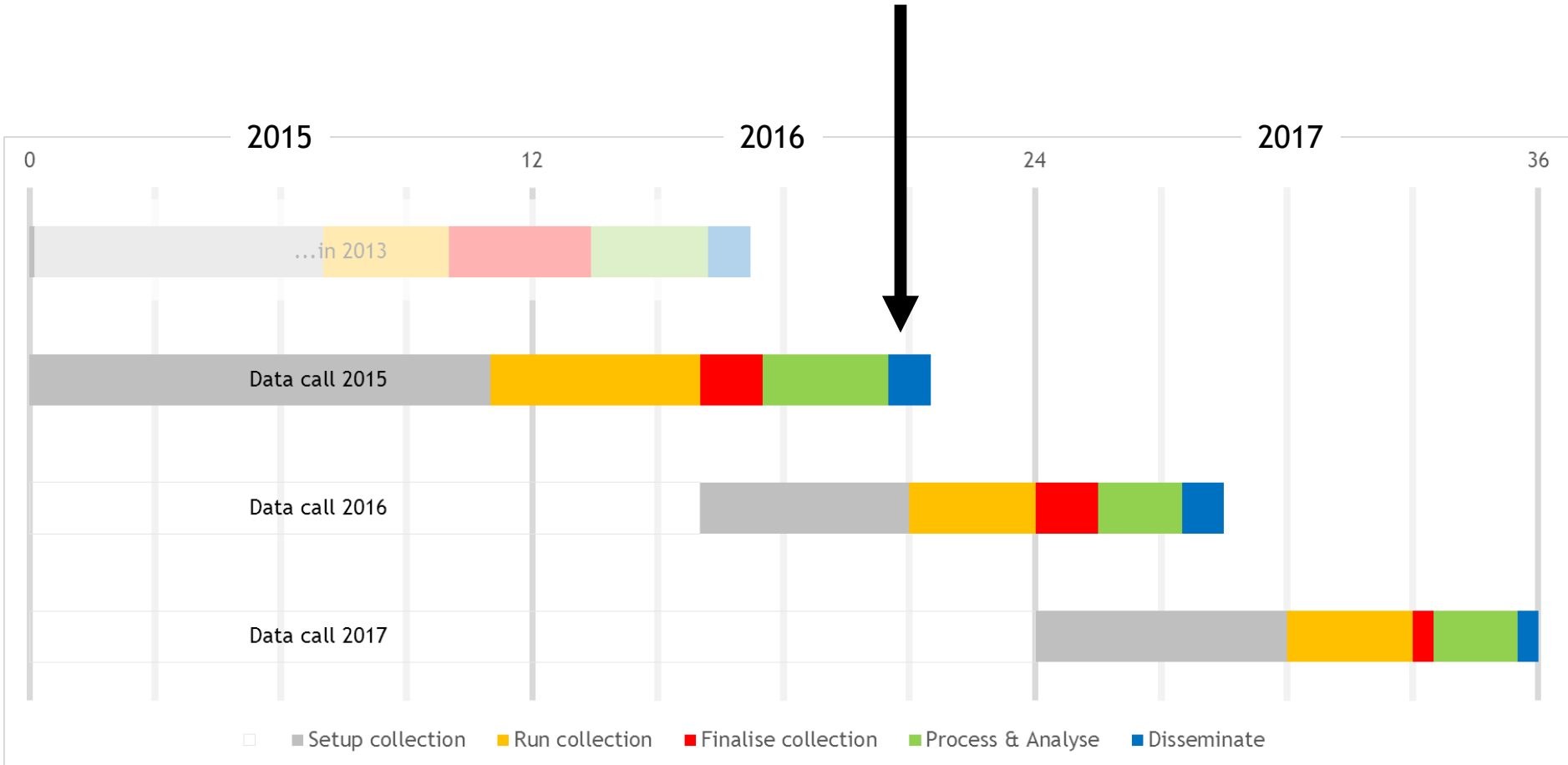

- WISE-1 - Emissions
- WISE-3 - Water Quantity
- WISE-4 - Water Quality

- Data reported in the current data call, plus legacy data*

* *where it fits the current model,
“old” Waterbases will remain online*

Spatial data

- WISE-5 - for EIONET spatial objects
- WFD Spatial - for WFD spatial objects
- Provisional dataset with legacy data*, plus WISE-5 reporting iff applicable

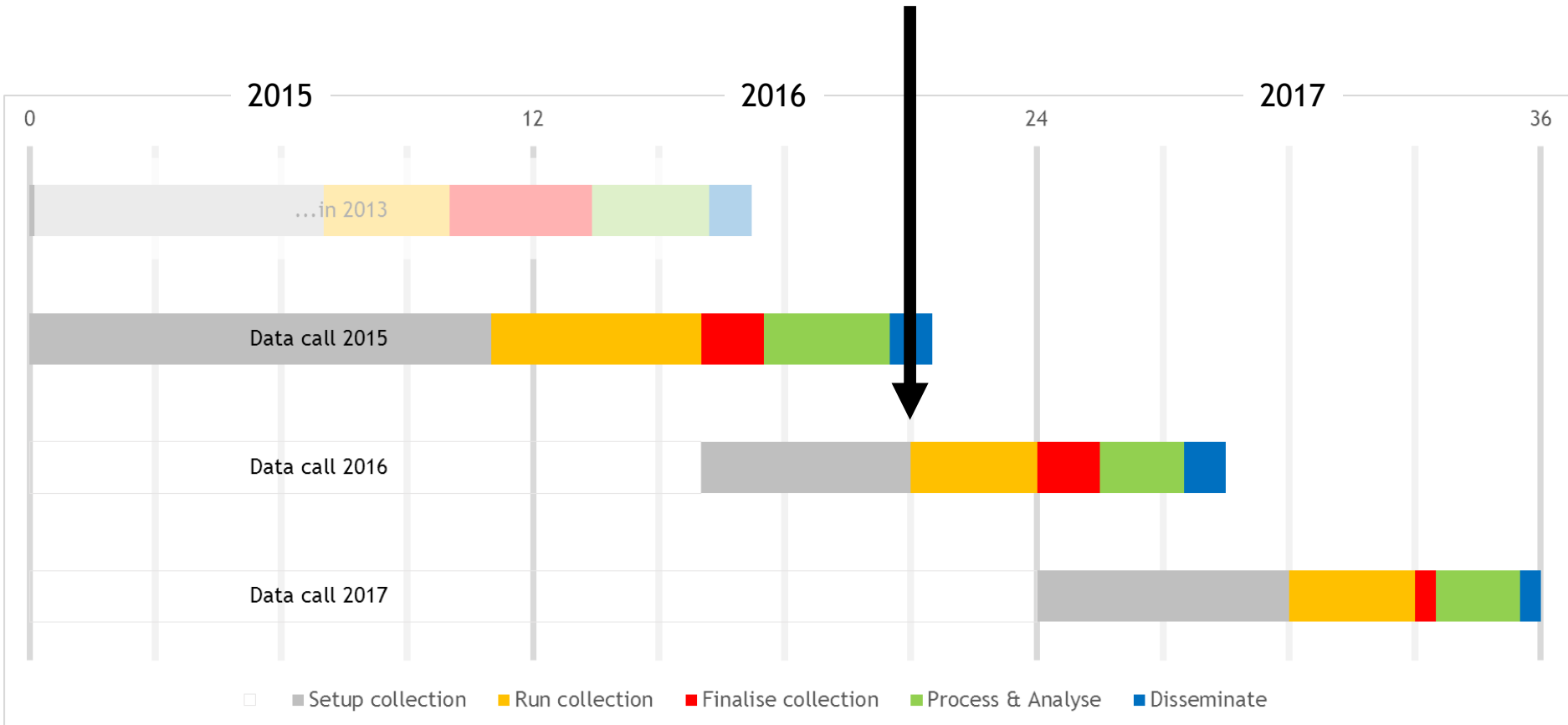

Meanwhile ETC will continue to...

- Support countries in clarifying any pending issues with the deliveries
 - *Example 1:*
Resubmissions, partial deliveries per “region”, per water body type, etc.
 - *Example 2:*
Any EIONET spatial objects to be reported under WISE-5 (i.e. not reported under WFD)

important information

- Given that the data model won't change, you can think of the WISE SoE data call as being “always open” (e.g. for resubmissions).
- Deliveries after the formal end of the reporting period are not published in the next Waterbase (but will be included in the next one after).

from the EIONET network side...

- NFPs and NRCs are fundamental in the process
- But also the Data Reporters (if different...)



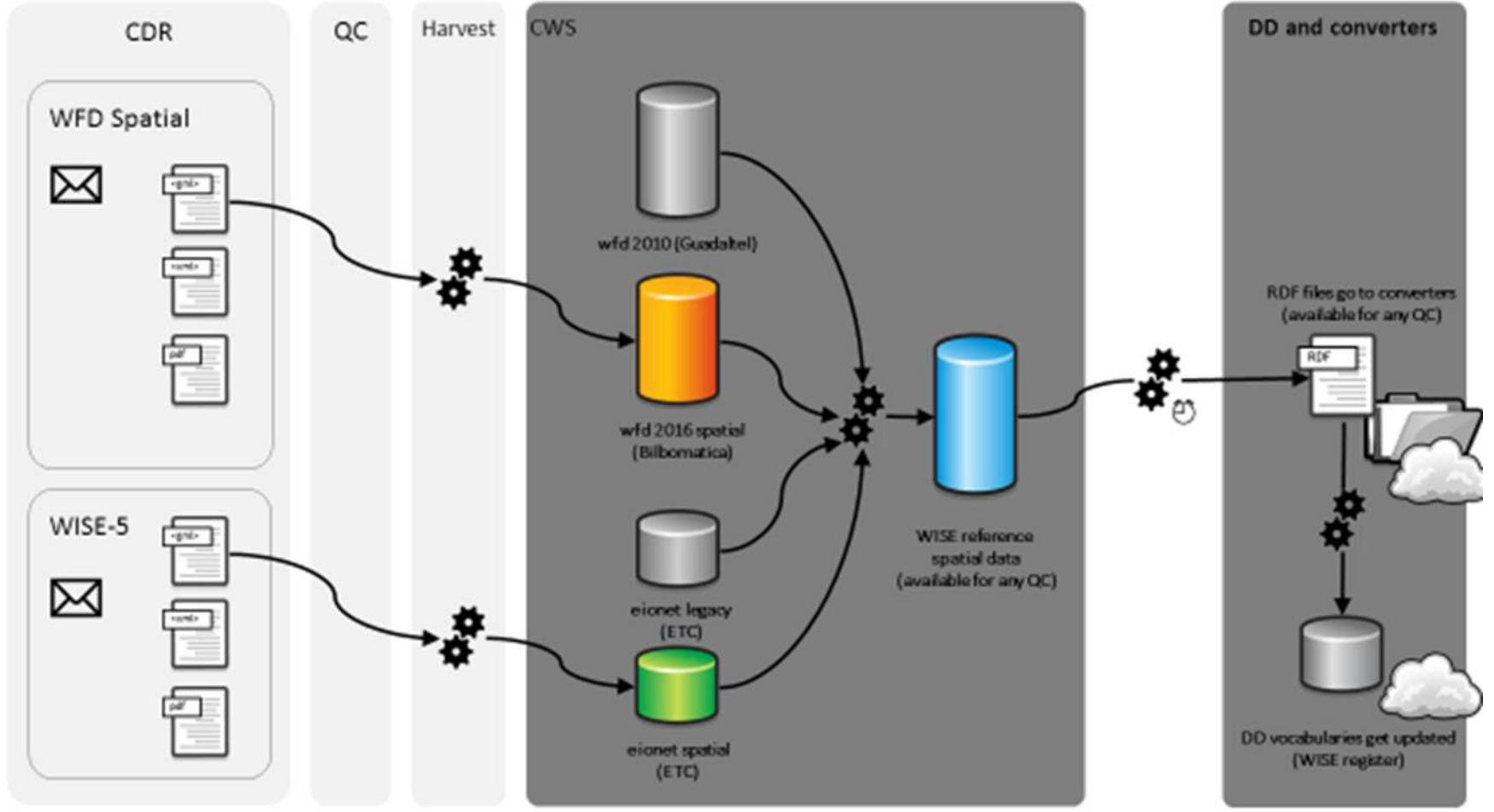
